# INTRODUCTION

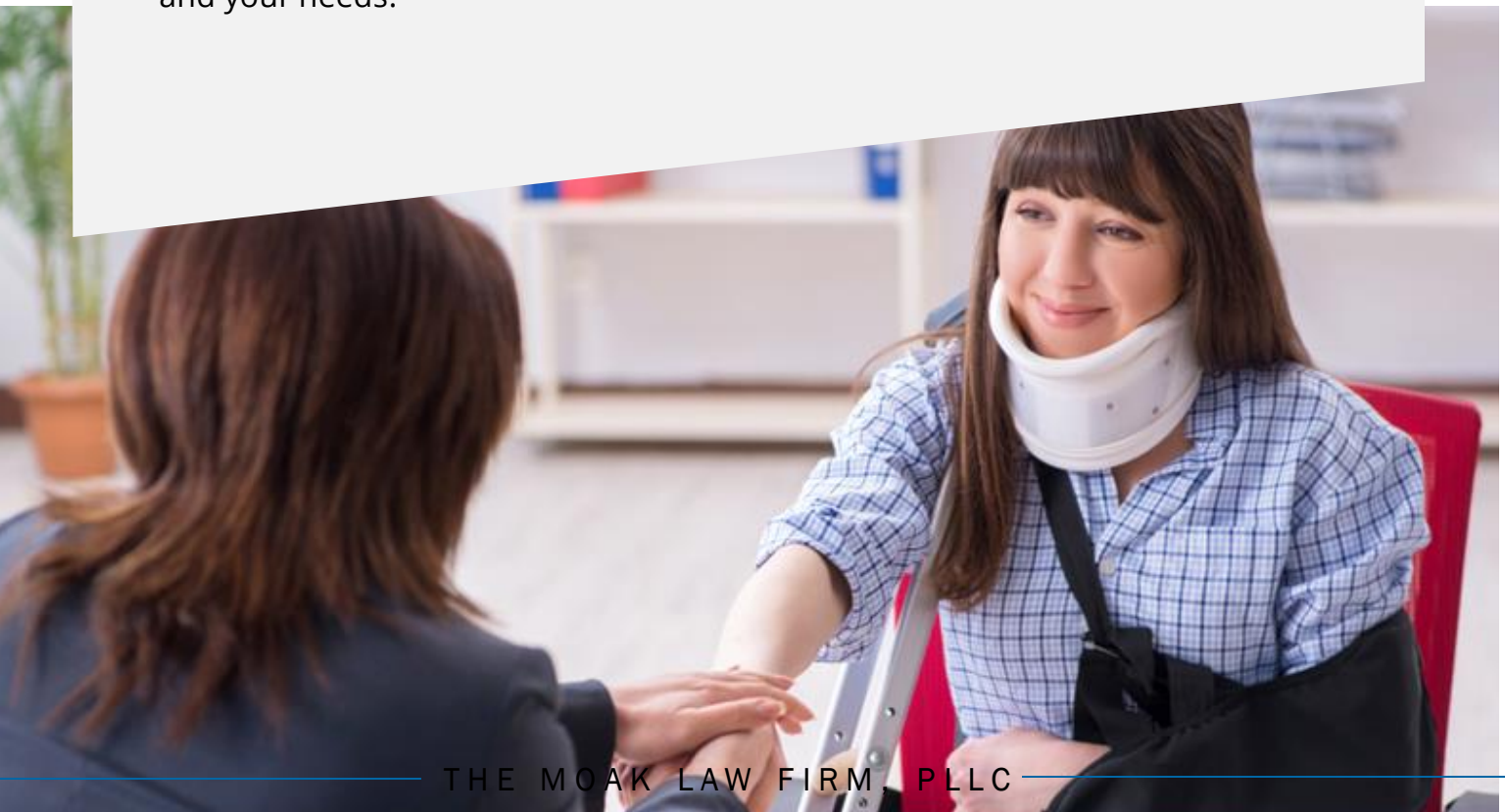

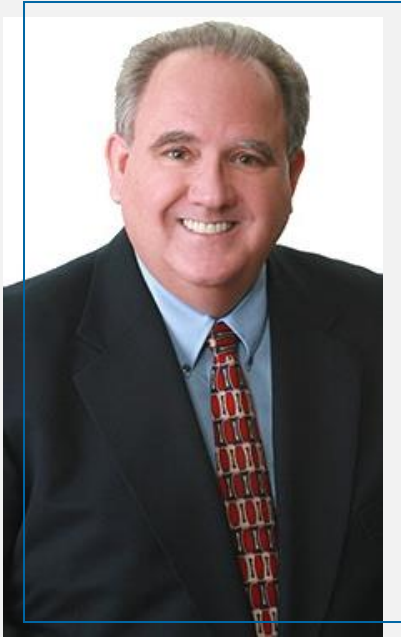
